This product combines chelated iron complexed with organic acids for rapid absorption and quick plant response at efficient use rates.

APPLICATION RATES

- Lawns:** Apply 2-4 oz per 1000 sqft every 21-30 days or as needed in sufficient enough water to cover.
- Fairways, Tees, Sports Turf:** Apply 2-4 oz per 1000 sqft biweekly or as needed in sufficient enough water to cover.
- Quick Green Up:** Apply 5-9 oz per 1000 sqft or as needed per application.
- Greens, Tees, Fine Turf:** Apply 1-3 oz per 1000 sqft weekly or as needed in enough water to cover.
- Ornamentals & Palms:** Apply 1-2 qts per 100 gal of water and spray to runoff as needed.

Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility of unknown mixes. Avoid tank mixing with heavy-phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions.
