APPLICATION RATES

Warm & Cool Season Turf:

For maintenance: Apply 3-6 oz per 1000 sqft.

For severe deficiency: Apply 8-12 oz per 1000 biweekly or as needed.

Ornamentals: Apply 1-2 quarts per 100 gallons of water and spray to runoff as needed.

Commercial Sod: Apply 1-3 gal per acre to green up turf as needed or before harvest.

Use sufficient water for thorough and uniform coverage of foliage or soil. Always make a bench test to check compatibility of unknown mixes. Avoid tank mixing with heavy-phosphate fertilizers or alkaline products. Apply in early morning or late evening, avoid excessive heat or dry conditions.
